### Risks inherent to the Activities

- The execution of jumps, runs, stunts, falls, somersaults, spins and acrobatic maneuvers that are missed or poorly executed;
- Individual fitness levels, allergic reactions, skills of participants;
- Temperature and/or other environmental conditions;
- My own actions, acts and/or omissions and/or those of Minor Child(ren) for whom I act as parent, legal guardian or person in charge (hereinafter referred to as " Minor Child(ren) in my care");
- In addition, fatigue, dizziness, or health problems may reduce reaction time and increase the risk of accidents.

*I understand that the description of these risks is not exhaustive and that other unknown risks may result in injury, illness or death. I acknowledge that I have been informed of the inherent risks of the activities offered at O-Volt.*
